# What is Medicaid?

- Provides Health Care coverage, including services and supports, to low income individuals, families, elderly and disabled populations
- Shared federal and state funding
- Program administered by the State of RI
- > **NOT** Medicare
- > Always the payer of last resort

# **Doors of Eligibility**

- Eligibility criteria is different for each program
- Programs rely on income &/or asset levels for determining eligibility.
- Some of the programs require a level of care criteria as well.
- All doors lead to the Medicaid program!



### **Populations Eligible for Medicaid**



- Individuals, Families, Children, and Pregnant Women
- Elderly, blind or disabled
- Children in Substitute Care (out of home placement)
- Children with special health care needs (CSHCN) eligible through Supplemental Security Income (SSI) or Katie Beckett
- Children covered by subsidized adoption agreements

## One-size does NOT fit all...

- Different programs fit different needs of the individuals applying
- The majority of Medicaid recipients are enrolled in "managed" care plans today.
- Some people are still receiving what is called Medicaid "fee for service"

Social Security Supplemental Income



- State Foster Care/DCYF
- Adoption Subsidy/DCYF



- RI's health insurance program for families with children, pregnant women, children under age 19.
  - Enrollees receive most of their medical care through participating health plans
  - "Out of Plan" benefits are coordinated by the health plan but paid for as "fee for service" through the RI Medicaid program

- RIte Share is Rhode Island's Premium Assistance Program that helps RI families afford health insurance through their employer by paying for some or all of the employee's cost.
- The monthly premium depends on your annual income and household size.
- The health plan and benefits are those offered by the employer and Medicaid is your secondary insurance.

### **RIte Care/RIte Share Benefits**

#### Services In-Plan

 Physician, hospital, behavioral health (mental health and substance abuse), laboratory, x-ray, pharmacy, PASS, Respite, HBTS – including ABA, physical therapy, occupational therapy, speech/language therapy and durable medical equipment (DME) - including assistive technology (Health Plan ID card)

#### Services Out-of-Plan

 Dental Services, services identified through an Individualized Education Plan (IEP), Certified Lead Center services (Medicaid card - white card with blue anchor)





# **Katie Beckett**

- Katie Beckett is an eligibility category in the RI Medicaid Program.
  - Parents' income and resources do not count when determining eligibility for the child.





### Eligibility for Katie Beckett (KB) in Rhode Island

- Be under age 19
- Be a Rhode Island resident and U.S. citizen or eligible non-citizen
- Live at home
- Meet the income and resource requirements
- Meet the Social Security Administration's definition of disability
- Require an institutional level of care



# **Definitions for Katie Beckett**

# What is meant by the Social Security Administration's disability requirement?

The Social Security Act requires that a child must have a physical or mental condition, or a combination of conditions, that results in "*marked or severe functional limitations."* This means that the condition(s) must very seriously limit the child's activities. Additionally, the child's condition(s) must have lasted, or be expected to last, at least 12 months or must be expected to result in death.

#### How does EOHHS determine disability?

 A team of licensed professionals at OHHS reviews the clinical information provided and makes a disability determination using the Social Security Administration's criteria (above), as well as Level of Care Guidelines (<u>http://www.eohhs.ri.gov/Portals/0/Uploads/Documents/kbeckett\_guidelines.pdf</u>).

# Katie Beckett Application

- Parents should call the Katie Beckett Unit to have them mail an application.
- Documents needed for the application:
  - an application for RI Medicaid,
  - Medical Evaluation form (to be completed by the child's physician),
  - Parent Questionnaire, (aka "A Day in the Life")
  - Provide proof of child's income and resources,
  - Provide information about other health and dental insurance.





- The Katie Beckett Unit has 90 days to approve your child's application.
- You will receive a call/letter when you are either approved or denied.
- Your child will be recertified every year for the financial information and as necessary for clinical recertification.





### Katie Beckett Appeal



- If your child is denied when it's a <u>new application</u> you can appeal within **10** days of the date on the denial letter.
- If a child is already active on Medicaid, in order to keep their Medicaid active you must appeal within **10** days and the child's Medicaid will continue during the appeals period
- If your application is denied after applying for Katie Beckett and you feel that you need more support understanding the process, call the RIPIN Parent Consultant at 462-0633.



#### Supplemental Security Income (SSI)

- A child younger than age 18 can qualify if he or she meets Social Security's definition of disability for children, and if his or her income including all other family members income and resources fall within the eligibility limits.
- SSI makes monthly payments to people with low income and limited resources who are 65 or older, or blind or disabled.
- The amount of the SSI payment is different from one state to another because some states make an additional state SSI payment.



# Supplemental Security Income (SSI)

- To receive SSI payments, a child must meet two sets of eligibility criteria:
  - 1. Financial criteria based on the income & resources of the child & family
  - 2. Medical criteria about the child's impairment or combination of impairments.
  - The local SSA office decides if a child's/family's income and resources are within the SSI limits. In making that decision, the Social Security office must consider the income and resources of parents/guardians who are living in the same household with the child.

# **DCYF/Foster Care**

- Children in DCYF/Foster Care may be eligible for Medicaid if they are without insurance through their family.
- Children w/Special Needs can be eligible for Medicaid via SSI.
  - The state would receive the cash benefit for the child in state care.
- Children are enrolled in RIte Care and would have a managed care plan.





# **Adoption Subsidy**



- The adoption subsidy program provides financial & medical assistance to make adoption possible for children with special needs awaiting adoption in the custody of DCYF or in certain situations a non-profit, private licensed child-placing agency.
- The provision of adoption subsidy, children w/ special needs can be provided with permanent adoptive families & enjoy the benefits of family security, love & nurturing.

### Which Door to Knock On?




**RIte Care/RIte Share-** Income eligibility for families, pregnant women, or children;



- **Katie Beckett-** Income of child only, SSI definition of disability, level of care criteria and financial eligibility;
- **SSI-** Income and resources of family and SSI definition of a child disability;
- **Foster Care-** child in state custody & without parental health insurance;
- **Adoption Subsidy-** child in state custody with special needs & ready for adoption or adopted.

### Medical Assistance Card Also known as "The Anchor Card"



Everyone enrolled in Medicaid receives one of these cards.

- Medical services
  - Dental/Vision Services
  - Behavioral Health Services
- Pharmacy
- Parking fees may be waived at Hasbro
- Transportation to medical appointments
  - Through MTM
- WIC

- Early, Periodic Screening, Diagnosis and Treatment (EPSDT)
  - EPSDT includes such services as CNA, private duty nursing, Cedar Family Centers Services, Applied Behavior Analysis (ABA), Home Based Therapeutic Services (HBTS), Personal Assistance Services and Supports (PASS), Respite (LOC requirement), Kids Connect
- Durable Medical Equipment
  - diapers/feeding supplies
- Disability pass for state parks & beaches (SSI & KB)
- RIPTA Disability Pass (reduced rate)
