# Navigating Rhode Island Community Health Worker Medicaid Reimbursement

The RI State Plan Amendment (SPA) defines Community Health Worker (CHW) services as preventive health services. Covered CHW Services may be provided in a clinical or community setting. ### Reimbursement Rate (as of 7/2024)

CHW services are billed in fifteen minutes increments using the Healthcare Common Procedure Coding System (HCPCS) procedure code; T1016 – Case Management

T1016 – without a modifier will be used when billing for services rendered to an established patient - \$12.71 T1016 – with the U3 Modifier will be used when billing for services rendered to a new patient - \$16.53

T1016 – with HQ Modifier will be used when rendering services in a group setting - \$4.66 (each eligible Medicaid member)

#### Who Can Provide CHW Services:

- 1. Individuals certified by the Rhode Island Certification Board (RICB) as a CHW.
- 2. Individuals with a plan to work toward RICB certification, to be achieved within 18 months. RI Medicaid does not define what counts as "having a plan." However, if an individual does not complete RICB certification within 18 months, their services will not be reimbursable by Medicaid until they complete that certification.

### Other Things to Consider:

- Patient/Client must be enrolled in Rhode State Medicaid.
- All services must be medically necessary for the individual.
- A recommendation by a licensed healthcare practitioner must be made before billable CHW services are rendered. If a CHW conducts a screening without a recommendation, that screening is not billable.

- 1. Health Promotion and Coaching
- 2. Health Education and Training
- 3. Health System Navigation and Resource Coordination
- 4. Care Planning
